While Camp Ocoee will make every attempt to provide reasonable accommodations for mentally and physically challenged children, the camp will not accept children that are (1) of danger to themselves, (2) of danger to others, (3) a disruption to the normal activities making it unreasonably difficult for other children to enjoy camp programs. Any of the above reasons will be grounds for dismissal from camp. A parent or legal guardian must discuss with the camp director any special conditions or circumstances involving his/her child. This must be completed prior to registration so that we can advise you as to whether we can make a reasonable accommodation for your child.

I, the undersigned parent or legal guardian, approve this registration and certify that the camper is capable of an overnight camp experience. I grant permission for the camper to participate in all planned camp activities including but not limited to out-of-camp trips by van or bus, hiking, horseback riding, and/or boating (the Activities). I am aware and understand that the Activities are potentially dangerous and involve the risk of injury, temporary or permanent disability, death, property damage, and/or financial loss. In case of an accident or illness, the YMCA is authorized to secure emergency medical treatment. All reasonable efforts will be made to contact the camper's parent or legal guardian immediately. I hereby authorize the medical personnel selected by the Camp Director to provide necessary medical treatment; to release any records necessary for insurance purposes; and to provide or arrange necessary related medical transportation for my child. I understand that no medical insurance is provided by YMCA Camp Ocoee or the YMCA of Chattanooga and that I am solely responsible for all costs related to such medical treatment and related medical transportation and/or evacuation. I understand that the YMCA assumes no responsibility for injuries or illnesses which my child may sustain as a result of his/her physical condition or resulting from his/her participation in the Activities. I hereby voluntarily release and discharge YMCA Camp Ocoee/YMCA of Chattanooga, its officers, directors, managers, agents, contract services, employees, and volunteers from any and all claims for injury, death, property damage, or financial loss which my child may suffer as a result of his/her participation in the Activities. The YMCA is not responsible for lost, stolen or damaged personal property. I hereby irrevocably permit, authorize, grant, and license YMCA Camp Ocoee and the YMCA of Chattanooga the rights to use photographs and/or videos of the camper named on this registration as may be needed for promotional purposes and public relations programming.

If Camp Ocoee receives written notification of cancellation prior to April 30, 2027, I will receive a full refund of all fees paid. Cancellations made less than 2 weeks prior to the start of your respective session will forfeit all previous payments.
